RENTAL AGREEMENT & BOAT SAFETY CHECKLIST

Those required to complete a rental boat safety checklist must carry on board the co-signed (customer and renter)
section of the Rental Boat Safety Checklist as proof of competency for duration of the rental.

Boating Safety Rules

I the pleasure craft operator: Name _

• Confirm that there are the appropriate number and sizes of approved floatation devices in the boat for the number of persons on board. They must fit and should be worn. I am aware that persons operating a pleasure craft without the appropriate number and sizes may be subject to ticketing and/or a fine.

_ I, Agree to the following

- Am aware that it is illegal to operate a pleasure craft, or to permit others to do so, when under the influence of alcohol, narcotics, or barbiturates
- Will only allow people who have completed and signed a Rental Boat Safety Checklist, valid for the duration of the rental or have proof of competency to operate this pleasure craft. I am aware that persons operating a pleasure craft without proof of competency may be subject to a fine and/or ticket.
- For the Safety of all Guests: No Towing Water crafts, Tubs, Jet Skis, or any Towing of any kind on Seadoo's or Boat rentals at Graceland Cottages.
- Have been shown how to use and know the location of safety equipment required under the small vessel registration. I am aware that persons operating pleasure craft without the required safety equipment may be subject to a ticket and/or fine.
- Understand that the pleasure craft fitted with motors must keep clear of non-powered pleasure craft, also responsible for my own wake and wash and the effects it can have on other pleasure craft, property, and wildlife.
- When involved in an accident must stop, offer assistance, and give identity.

Operation of The Boat

- Am aware of how to responsibly operate a pleasure craft and to share the waterways in a
- courteous and respectful
- Manner with others involved in all water related activity.
- Confirm that the maximum load capacity and number of persons in the pleasure craft will not exceed the amount stated on the capacity plate. If a capacity plate is not fitted, the load capacity and number of people shall not exceed the manufacturer's recommendation. I am aware of the proper way to distribute weight in pleasure craft.
- I have been shown the proper procedure for starting and shutting off the engine and will make sure no people are in the water within the vicinity of the pleasure craft before starting and while running the motor.
- I have shown and understand the operation of the throttle and gear shift lever.
- Know where and how to operate the ignition cut off switch.
- I am aware of how to respond to grounding, capsizing, and reboarding.

Local Hazards and Conditions

I am aware of local navigation aids and the meaning as well as local hazards and local regulations.

I shall always maintain a proper lookout for other boats, navigational hazards and changes in weather conditions, changes in weather happen quickly creating dangerous conditions for boaters.

Boat Damage Deposits:

All Boat rentals require a one-time damage deposit & will be reimbursed to the renter after the Boat rental is returned without damages. The Deposit can be E-transferred / cash deposit held to the office at Graceland Cottages.

Pontoon Rentals Damage deposit is \$1,000

Motorboats Damage deposit is \$500.00

Seadoo Damage deposit is \$500.00

Damages

- Agree to be responsible for ALL damage to and loss of boat, motor, and equipment during the rental.
- All such damage and/ or missing items shall be determined by Graceland Cottages management and at their discretion will form part of the rental cost and be deducted from my damage deposit or loss of return of damage deposit.
- If mistreatment, abuse, or any other misbehavior is observed at any time during the rental period, this contract can & will enforce an immediate end to any further use of any watercraft with no return or refund of any kind.
- Each principal driver must be at least 25 years of age and have a valid driver's license. Customers must present their driver's license. Anyone 18 + years may operate a PWC with the principal driver supervising.

Boating Safety Message

- Wear your personal flotation device. It will not work if not wearing. You must have one Canadian
 Approved floatation device for each person on board.
- When on the water abstain from drinking alcohol, the effects of alcohol on your body (due to motion of boat, sunlight, waves, wind) can be 3 times what they are on shore.
- Every year approx. 200 people die while boating in Canada. The same kind of fatalities are repeated each year and almost all are preventable.
- When operating a boat, use courtesy and common sense to not create a hazard, a threat, a stress, or an irritant to yourself, to others, to the environment or to wildlife.
